## SET FREE ALASKA EXPANDS PROGRAMS AND BOARD FOR 2021

## PALMER, ALASKA-

Set Free Alaska, the CARF certified non-profit organization serving men and women focusing on rehabilitation from substance abuse addiction, has expanded to programs, and grew the Board of Directors.

"This year, despite some unique challenges, we've had an excellent opportunity of growth in the community of Homer, Alaska, where we opened a new men's sixteen-bed facility," said Executive Director Philip Licht. He added, "We added two incredible board members, and we opened a quarantine house in Wasilla assisting with COVID related challenges."

The Alaskan agency offers residential treatment for men at the Homer Compass location and for women at the Valley Oaks Wasilla facility, Outpatient services in Homer and Wasilla, Children's Behavioral Health for Children and Adolescents, Peer Support, a Workforce Development Program, and most recently, have set up quarantine options related to the COVID-19 crisis.

The Set Free Alaska Board of Directors met recently in Homer, Alaska, to prepare for the upcoming year of growth and the management of existing businesses in the Southern Kenai Peninsula and Matanuska Valley.

"We use a holistic approach, where the client is treated with respect and dignity from day one. We are a Christian organization and that resonates in every decision and action we make. The results of excellence from our program speak louder than words. We see lives changed daily!" added Licht.

Mr. Jeremy Creech




